Minutes from October 13, 2019

California State Grange Foundation

First meeting of the California Grange Foundation was called to order by Director, Kent Westwood on October 13, 2019, during a recess of the 144th Annual Session of the California State Grange.

Item for discussion is the adoption of the By-Laws

Jeff Skinner, attorney for the State Grange, was asked to talk about the By-Laws for the Foundation and why they were written. He advised the members that during the lawsuits there were some areas of the previous by-laws which were not as clear as they could be. Using that premise, these by-laws were written to make sure that situation did not happen again.

It was noted by Bill Booth that the fiscal year had a typo – it was accepted by the members to correct the fiscal year to January 1 to December 31.

It was moved by Martha Stefenoni to adopt the By-laws of the California State Grange Foundation as presented. Seconded. Discussion.

It was moved by Steven Hood to amend Article 3 (Members). By changing "Master/Spouse to "Two selected representatives". Seconded. Debate. Motion carried. Amendment adopted.

It was moved by Katie Squire to remove the word "Seven (7) on page 2, Article 4, Section 1. Seconded. Discussion. Extensive discussion. Determined it will be necessary to change the resolution passed during the State Session to add the Treasurer, Christina Webster, to the Articles of Incorporation. Katie withdrew her motion and the second also withdrew.

Question posed to Jeff Skinner Article 10 – Amendments – is there a specific method to amend the by-laws. Jeff recommended the same format be used as the State Grange, except any resolutions would be directed to the State Grange Foundation and acted upon during the Foundation meeting.

Paul Hyland called for the Previous Question. Seconded. Withdrawn by the maker.

It was moved by Rachel Britten to amend the Objectives by adding to additional points:

- (g) preservation of farmland
- (h) support and encouragement of existing, as well as, beginning farmers and ranchers. Seconded. No discussion. Vote taken. Motion carried. Amendment carried.

By-Laws as amended on the floor.

It was moved by Rachel Britten to amend to strike Bob Clouse and add William Shaw as the original director and to add Christina Webster. Seconded. Vote taken. Motion carried. Amendment adopted.

It was moved by Bill Booth to amend at Section 4 page 3, after Vice-President add Secretary, Treasurer and strike 5 and change to 3. This aligns with the current Board of Directors for the State Grange. Seconded. Vote taken. Motion carried. Amendment adopted.

By-Laws as amended on the floor.

It was moved by Paul Hyland to call for the Previous Question. Seconded. Motion carried. Debate closed.

By-Laws as amended on the floor. Vote taken. Motion carried. By-Laws of the California State Grange Foundation are adopted.

Foundation meeting was recessed for the purpose of developing a resolution for the procedure to elect Board members. Brother Kent appoint the committee to write resolution for election of officers. Erica Kroesen, Rachel Britten, Jini Reynolds & Steven Hood.
